Hit the Open Road: Must-Ride Routes in 2025

Good weather is right around the corner, and for motorcyclists that means one thing...it's time to plan those unforgettable road trips. There's nothing quite like feeling the wind against your jacket, hearing the roar of your engine, and watching the open road stretch ahead of you. Whether you're looking to ride down scenic highways, mountain twists, or winding coastal roads, these summer rides promise breathtaking views and unforgettable memories.



The Pacific Coast Highway (California)

Known as one of the most iconic routes in the country, California's Pacific Coast Highway offers ocean views, high cliffs, and rides through small seaside towns. Starting from Monterey and winding down to Morro Bay, you'll pass Big Sur's coastline and the famous Bixby Creek Bridge. If you want an even longer ride down the coast, start in San Francisco and travel all the way down to Los Angeles. The clear skies of summer and cool ocean breezes make this ride truly wonderful and serene.



Beartooth Highway (Montana and Wyoming)

For those seeking a thrill, the Beartooth Highway offers sharp turns, climbs up steep roads, and some of the most amazing alpine views in the country. Starting near Billings, Montana, and winding through the Absaroka-Beartooth Wilderness, this high-altitude ride leads right into Yellowstone National Park. Summer is the perfect time to take the trip down this road, as the pass often stays closed due to snow until later in the spring.



Tail of the Dragon (Tennessee and North Carolina)

If twists and turns are your thing, the Tail of the Dragon is a must-ride route. With over 300 curves packed into just 11 miles, this ride is only for those with the focus and skill to get through to the end. Located in the Great Smoky Mountains, the scenic beauty adds a layer of enjoyment to the adrenaline of winding through the curved roads. Summer brings lush greenery and vibrant wildlife, and you just might see the occasional black bear!



Lake Superior Circle Tour (Midwest States and Canada)

Closer to home for Midwest riders, the Lake Superior Circle Tour covers over 1,000 miles around the largest freshwater lake in the world. The route passes through Michigan, Wisconsin, Minnesota, and Ontario, Canada, offering views of rocky shorelines, towering forests, and charming small towns. Highlights along the route include Pictured Rocks National Lakeshore and the wonderful scenery in Thunder Bay.

\$1,665,000 for Motorcyclist's Children After Insurance Company Tried to Blame the Deceased

On a sunny summer day, our clients' father was traveling through Rockford on his motorcycle when a car exited a parking lot without stopping, directly in his path. As a result of the collision, the man lost his life leaving behind six children.

Attorneys Vito Manicioto and James Carlson immediately began investigating the crash. It was discovered that the incident was captured on video from a nearby business. Although the video showed the defendant not stopping before entering the roadway, it also showed the motorcyclist exceeding the speed limit.

The insurance company tried settling the case for \$100,000. This offer was immediately rejected and a lawsuit was filed by Attorneys Manicioto and Carlson. Once the lawsuit was filed, the insurance company dug in its heels and tried painting a picture that the accident was due to the negligence of the motorcyclist alone.

Multiple experts were hired by Attorneys Manicioto and Carlson to not only show the liability of the defendant and his employer, but also to demonstrate the financial loss to the motorcyclist's family. The case was intensely litigated and after two mediation attempts, our attorneys were able to successfully recover \$1,665,000 for the motorcyclist's children.

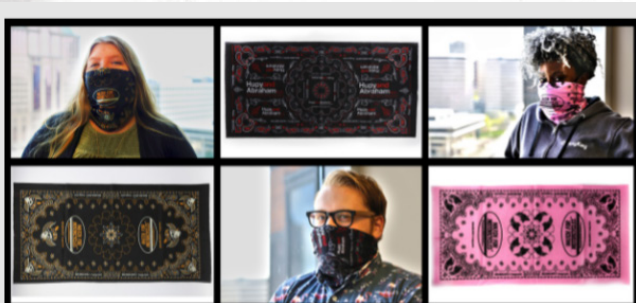

Five Things You Must Do After a Motorcycle Accident

Motorcycle accidents can be overwhelming and scary, but knowing which steps to take immediately afterwards can make all the difference in ensuring your safety and protecting your rights.

Here are five things you should do if you're ever involved in a motorcycle accident:



1. Prioritize Safety:

Your health and safety come first. If you're able, move to a safe location away from traffic. Check yourself for injuries and call 911 right away. Whether you think you're hurt or not, it's essential to get medical attention. Some injuries like concussions or internal bleeding may not show symptoms right away.



2. Document the Scene:

If you're able to, gather evidence at the scene. Take photos of your motorcycle, other vehicles involved, injuries, and road conditions. This evidence could be very important for insurance claims and to help you if legal action is needed.



3. Exchange Information:

Get contact details from anyone involved, including names, phone numbers, driver's license numbers, and insurance information. Try to gather contact information from any witnesses who saw the accident as well.



4. Report the Accident:

File a police report, even for minor accidents. A police report provides an official record of the incident and can be crucial later down the line.

CASE RESULTS:

\$120,000 for Motorcyclist Rear-Ended at Traffic Light

Our client was injured while driving a motorcycle after being rear-ended at a traffic light while waiting to make a left-hand turn. As a result of the collision, he experienced pain in his neck, back, chest, left elbow and left shoulder. He sustained a torn rotator cuff and labrum, which required surgical intervention.

Attorney Eric Schade was able to settle his claim with the liability carrier for the policy limit of \$50,000. After convincing our client to allow us to pursue a claim for underinsured motorist coverage, Attorney Schade won that claim for an additional \$70,000 for a total settlement of \$120,000 without having to file suit.

In June, our client was a passenger on a friend's motorcycle when it crashed in rural Fond du Lac County. She suffered multiple fractures and road rash.

Attorney James Shilobrit was able to win the case for a total of \$100,000 from two different insurance companies in just five months.

\$50,000 for Motorcycle Client After Insurance Companies Deny Claim

Our client was driving a motorcycle when he was injured after striking a vehicle traveling in front of him. The vehicle he struck had signaled to make a right-hand turn, but made a U-turn instead. As a result of the incident, he experienced head, neck, chest, back pain and sustained a hairline fracture in his jaw.

Despite an initial claim denial from both the liability insurance carrier and his underinsured motorist carrier, Attorney Eric Schade was able to resolve his claim for \$45,000, plus a waiver of the \$5,000 medical payments coverage subrogation interest without having to file suit.
